## Part A: Pupil premium strategy plan - Statement of Intent

Our intention is that all pupils, irrespective of their background or the challenges they face, make good progress and achieve high attainment across all subject areas. The focus of our pupil premium strategy is to support disadvantaged pupils to achieve that goal, including progress for those who are already high attainers.

High-quality teaching is at the heart of our approach, with a focus on areas in which disadvantaged pupils require the most support. This is proven to have the greatest impact on closing the disadvantage attainment gap and at the same time will benefit the non-disadvantaged pupils in our school. Implicit in the intended outcomes detailed below, is the intention that non-disadvantaged pupils' attainment will be sustained and improved alongside progress for their disadvantaged peers.

Our approach is responsive to common challenges and individual needs, evidenced by diagnostic assessment. The approaches we have adopted complement each other to help pupils excel. To ensure they are effective we will:

- ensure disadvantaged pupils are challenged in the work that they're set
- act early to intervene at the point need is identified
- adopt a whole school approach in which all staff take responsibility for disadvantaged pupils' outcomes and raise expectations of what they can achieve

#### **Challenges**

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Less experience of pre-school settings resulting in lower attainment on entry.
2	Children may have had less access to books, and other resources which support home learning eg, devices, wifi, paper, pens, pencils, reading books, particularly with the cost of living crisis.
3	Gaps in prior learning
4	Able and more able pupils achieving potential
5	Children may have had less opportunity to travel outside of the immediate area or to access a wide range of opportunities and experiences.
6	Housing challenges which carry a significant negative impact on children, including tiredness, personal hygiene, hunger, fear and anxiety.
7	Families where parents/carers do not speak English as their first language and as a result may struggle to support their children's learning at home

# **Intended outcomes**

## Part B: Review of outcomes in the previous academic year

#### Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2024 to 2025 academic year.

Our internal assessments during 2024/25 suggested that the performance of disadvantaged pupils is returning to those that pre-date COVID. Pre-validated data suggests that at the end of KS2, 89% of pupils with a pupil premium eligibility achieved age-related expectations in reading, 89% in writing and 78% in maths.

Although there remains some gaps in learning which have still to be addressed, targeted interventions have shown to be most effective for the pupils of St James the Great and will continue

The impact has been further mitigated by our resolution to maintain a high quality curriculum, and wherever possible to provide a wide range of additional opportunities and educational visits for all children, particularly those who are living in emergency housing, small flats and apartments.
